Important matters to consider when working, receiving scholarships and studying in Finland

Financial aid for students from FPA/KELA



- If you are not a Finnish citizen and have come to Finland for study purposes, the general rule is that you **cannot** get financial aid from Finland
- However, you may qualify for financial aid if
 - you have been granted a continuous (A) or permanent (P) residence permit or an EU residence permit for third-country nationals (P-EU or P-EY). If you are a citizen of another EU or EEA country or of Switzerland, the family member of such a person, or a citizen of a Nordic country, you only have to register your right of residence or present your residence card.
 - if you are living in Finland permanently and
 - you have arrived in Finland for some other reason than to study. Such a reason can for example be employment, family ties or return migration.

Financial aid for students from FPA/KELA



- Study grant
- Government guarantee for a student loan
- (housing supplement, only in special cases)
- General housing allowance



Financial aid for students from FPA/KELA



- To remember:
 - The amount of credits (academic year)
 - Income limits (calendar year based on support months)
 - Master degree has 23 support months
- Be in direct contact with KELA/FPA as all your cases are individual.

Åbo Akademi University scholarships for students



- Presented in the scholarship guide (almost 100 scholarship funds)
- Most of the scholarships come from funds that are held in trust by the <u>ÅAU Foundation</u>
- For degree students at AAU who are enrolled as present
- Annual application process is in September
- Scholarship decision based on:
 - the wishes of the donators to the different funds
 - study performance

Åbo Akademi University scholarships for students



Further devided into:

- Scholarships with a language clause,
 i.e. scholarships for students with
 Swedish as their first language
- Scholarships without a language clause, i.e. scholarships, which can be applied for independently from the first language or in particular cases with a different first language than Swedish.

Three categories of scholarships:

- General scholarships are open for application for all degree students on bachelor/master level
- 2. Faculty scholarships are open for application for students studying a specific subject or at a specific faculty in accordance with the scholarship regulations
- 3. **Special scholarships** have special stipulations e.g. regarding background, specialisation in studies or life situation



Åbo Akademi University



scholarships for students

- Application time: Middle of September
- Processing of the application: 2-3 months after September deadline
- The scholarship decision is announced: November
- The scholarship is paid (in most cases): November/December
- Scholarships vary between 200 euros and 2000 euros (200-400 euros the most common amount)
- Information when application opens is sent to all students via email

Remember











Processing them takes a long time so do not apply for scholarships you are not in criteria for . So read the requirements!

You need to have study credits in peppi to be eligible for scholarships

Kindly note that decisions regarding scholarships are final and cannot be appealed against

- Two annual application periods: one in March/April and one in October/November
- The scholarship decisions are published 1-3 months after application deadline •

- Scholarships are not taken into account in the income control by FPA/KELA (study grant)
- Scholarships in Finland are tax free up to the amount of 26 269,46 € år 2024

- Residence permit for studies:
 - You may only work for an average of 25 hours per week during the academic terms.
 - The number of working hours is not restricted on a weekly level. This means that you can adjust your weekly working hours during the academic term, as long as you work for 25 hours a week on average.

You can work without restrictions at the times when your educational institution offers no
instruction, that is, during summer and Christmas holidays.

Keep in mind that as a student you are also required to pay the Student Union fee (full academic year: 76,50€, the autumn term only 48,00 € / spring term only 50,00 €) and the Health care fee if you are outside the EU, which is 36.80 € per term, which gives you access to the Finnish Student Health Service (FSHS).		

Advice



- Student discounts with student card exist
 - Travels (trains & buses)
 - Student restaurants
 - Some stores
- Make a budget for each month and make sure to be realistic and include student activities
- If you plan to borrow money, make sure you know it's safe
- Evening grocery shop discounts some food stores have a 21.00 o'clock discount so that all already marked 30% tags become 60% at that time. Mostly S-stores such as Prisma & S-Market (but this might vary). Ask in the store close to you
- RESQ Club is a no food waste app for stores, restaurants and cafes. At certain times they add their extra/left over/ soon expiring food on the app and one can book them
- Second hand stores are popular in Finland
- Get a bike or a bus pass
